Based on the provisions of the Company's Articles of Association and Financial Services Authority Regulation No. 15/POJK.04/2020, invitation for the Meeting will be announced on the IDX page, namely www.idx.co.id, eASY.KSEI via <https://akses.ksei.co.id> and the Company's page www.bbr.co.id on **May 29, 2026**.

Refer to the provisions in article 16 POJK No. 15/POJK.04/2020, 1 (one) shareholder or more representing 1/20 (one per twenty) or more of the total shares with voting rights can propose meeting agenda in writing to the Board of Directors no later than 7 (seven) the day before the invitation to the Meeting, **May 22, 2026**, by including the reasons and materials for the proposed agenda of the meeting referred to as long as in accordance with the applicable laws and regulations.
